

Liina Carr

Born in Estonia, 1968

Liina Carr was re-elected as ETUC Confederal Secretary at the Vienna Congress in 2019. Since 2002 she has been an active trade unionist at national, regional, European and international level. During Estonia's accession to the European Union, she was part of the trade union team that worked with the Estonian government to implement EU social and labour legislation in preparation for membership.

Her responsibilities include macroeconomic policy, economic governance and the European Semester, the European Pillar of Social Rights, social protection, external relations, implementation of UN Agenda 2030 Sustainable Development Goals in the EU and development cooperation, as well as human resources.

Liina has been a member of the European Economic and Social Committee since 2004, as a Vice-President of the Workers' Group, co-chair of the European Economic Area Consultative Committee, member of the Single Market Observatory and member of the Europe 2020 and other committees.

As ETUC Confederal Secretary from 2015-2019 she handled a wide range of issues including international trade, mobility, posting of workers and the European Labour Authority, migration, social protection, implementation of UN Agenda 2030 and development cooperation policies.

Her activities in these areas included

- ***intensive lobbying on the EU-Canada trade agreement (CETA) ensuring the replacement of the Investor-state dispute settlement mechanism by the Investment Court System and securing rejection of market economy status for China.***
- ***negotiating 'A European Partnership for Integration - Offering Opportunities for Refugees to Integrate into European Labour Market' with the European Commission, BusinessEurope, SMEunited, CEEP and EuroChambres.***
- ***revision of the posting of workers directive, obtaining a significant number of improvements to the Commission's proposal in order to ensure the principle of equal pay for equal work. Liina worked with the European Parliament, Commission, Member States and affiliates to include trade union demands in the draft regulation on the European Labour Authority.***
- ***Supporting the European implementation of the UN Agenda 2030 Sustainable Development Goals, through the Semester process and other EU policies. Liina worked to put the Decent Work Agenda (DWA) and social dialogue at the core of EU development policy and urged effective financing for EU development cooperation in the new Multiannual Financial Framework 2021-2027.***
